


## Indigenous Knowledge Program Funding Agreement (the "Agreement")

Marten Falls First Nation Project Team (Hereinafter called the "Project Team")

Dillon Consulting Limited (Hereinafter referred to as "Dillon")

OF THE THIRD PART

WHEREAS

WHEREAS Marten Falls First Nation ("MFFN") is a remote First Nation community in northern Ontario located at the junction of the Albany and Ogoki rivers, approximately 430 km northeast of Thunder Bay.

AND WHEREAS the MFFN community is currently only accessible by air and a winter road. Given the unreliability of the winter road, MFFN is proposing an all-season community access road (the "Project") to connect MFFN to Ontario's provincial highway network (i.e., Highway 643) to the south via the existing Painter Lake Road.

AND WHEREAS MFFN is represented by the Project Team to assist MFFN with a Provincial Environmental Assessment and Federal Impact Assessment (the "Assessments") to assess the potential Project effects and benefits.

AND WHEREAS as part of the Assessment the Project Team would like to engage FN in the Indigenous Knowledge Program (the "IK") and to complete a Project-Specific IK Study ( the "IK Study")

AND WHEREAS the FN has agreed to participate in the IK program and produce an IK Study specific to the Project area and community.

AND WHEREAS, specific to this Agreement, the Project Team has retained Dillon for the sole purpose of the administration of the receipt of the IK Study and payment of the funding for the IK Study to the FN as set out in this Agreement.

NOW THEREFORE THIS AGREEMENT WITNESSES that the Project Team, FN and Dillon (the "Parties") hereby agree as follows:

#### ARTICLE I: SCOPE OF SERVICES

1.1 Services by the FN. The FN shall complete and provide to the Project Team, an IK Study Report, covering the geographic area identified in Schedule A, with that degree of care, skill and diligence normally provided in the performance of an IK Study on projects of a similar nature.

1.2 Scope of Services. The FN shall complete the IK Study Report in accordance with the provisions as set out in the *MFFN Community Access Road Project - Indigenous Knowledge Program Guidance Document,* dated November 2020, a copy of which is attached as Schedule B.

ARTICLE II: Project Team Responsibilities

2.1 Information. The Project Team shall provide to the FN, in a timely manner, relevant information required to complete the IK Study.

ARTICLE III: FN RESPONSIBILITIES

3.1 Deliverables. The FN shall provide the following reports, upon the timelines set out:

- Preliminary Data (GIS)/Draft Report/Information, by no later than May 15, 2022
- Final IK Study Report and associated mapping/GIS files, by no later than June 30, 2022

#### ARTICLE IV: Compensation

4.1 Compensation. The Project Team agrees to compensate FN for the IK Report, in the amount of \$30,000, inclusive of all applicable taxes (the "IK Payment").

4.2 Schedule of Payments. Upon execution of this Agreement by all parties, the Project Team shall direct Dillon to pay the FN the IK Payment based upon the following schedule:

- An initial payment of \$10,000 within 30 days of the execution of this Agreement by all Parties,
- A second payment of \$10,000 within 30 days of receipt, by the Project Team, of the Preliminary Data (GIS)/Draft Report/Information,
- A final payment of \$10,000 within 30 days of receipt, by the Project Team, of the Final IK Study Report and associated mapping/GIS file.

Notwithstanding article 7.7, the FN here by directs Dillon to make the three individual IK Payments, payable to \_\_\_\_\_\_ and to deliver the payments to \_\_\_\_\_\_, and this shall be Dillon's good and valid authority to do so.

#### ARTICLE V: CONFIDENTIALITY, USE AND DISCLOSURE

5.1 Confidentiality. The Project Team and the FN have previously executed an Indigenous Knowledge Information Sharing Agreement (the "IK Agreement"). The Project Team and the FN Parties agree that all matters relating to the confidentiality, use and disclosure of the IK Report shall be governed by the IK Agreement. In the event of any conflict between terms of the IK Agreement and this Agreement, the terms and conditions of the IK Agreement shall govern.

#### ARTICLE VI: CONFIRMATION

6.1 Confirmation. The FN confirms that it will complete the *Final IK Study Report and associated mapping/GIS files* with due care, attention, and diligence.

#### ARTICLE VII: OTHER

7.1 Governing Law. This Agreement shall be governed by the laws of the Province of Ontario.

7.2 Entire Agreement. This Agreement (a) constitutes the entire agreement and understanding between the Parties with respect to the subject matter hereof and (b) supersedes all prior agreements, understandings, negotiations and discussions by or between the Parties pertaining to the subject matter of this Agreement. There are no warranties, representations or other agreements, whether oral or written, express or implied, collateral or otherwise, by or between the Parties pertaining to the subject matter of this Agreement except as set forth in this Agreement.

7.3 Acknowledge and Confirmation of Project Team and FN. The Project Team and the FN confirm and agree that Dillon's only obligations under this Agreement is the payment of the IK Payment upon the terms and conditions set out in Article 4.2. The Project Team and FN acknowledge and agree that Dillon shall have no other obligations or requirements, of any kind or nature whatsoever, with respect to this Agreement or the IK Study. The Project Team and the FN agree and acknowledge that Dillon makes no representations, and shall have no responsibility, as to the completeness of the IK Report nor any obligations or requirements regarding the timeliness of the draft or final IK Report to the FN or the Project Team.

7.4 Independent Professional Services FN. The FN is an independent professional services provider in performing services under this agreement, and accordingly it is further acknowledged that the FN is an independent contractor.

7.5 Assignment. Neither party may assign this Agreement without the prior consent in writing of the other party.

7.6 Modification and Waiver. This Agreement may not be modified, amended or supplemented except by written agreement of the Parties. No act or omission by a party, other than a written waiver, shall constitute a waiver of any provision of this Agreement. No waiver of any provision of this Agreement shall constitute a waiver of any other provision, nor shall any such waiver constitute a continuing waiver, unless otherwise specifically agreed in writing by the Parties.

7.7 Notices. All notices, instructions and other communications required or permitted to be given hereunder must be in writing and must be delivered via email, or mailed by first class mail, to the parties and at the addresses set forth, in the event of a notice being sent by first class mail the notice shall be deemed to be received by the addressee on the fifth business day after the mail is postmarked:

- Project Team insert address and contact person or title Qasim Saddique, Project Director (<u>qsaddique@suslop.com</u>) (might make sense to make it a single address for the Dillon office responsible for this work)
- FN insert address and contact person or title
- Dillon insert address and contact person or title

7.8 Inurement. This Agreement shall be binding upon the Parties, and shall continue in full force and effect in the event any Party is permitted to assign this Agreement or if there is any change in ownership, control or management of any Party.

7.9 Counterparts, Signatures and Retention. This Agreement may be executed in one or more counterparts, each of which is an original, and which, taken together, shall constitute one and the same agreement. The signing of a facsimile copy or portable document format (PDF) copy of this Agreement and any amendments thereto shall have the same effect as the signing of an original. The retention of an electronic version of this Agreement is permitted and the subsequent production of an electronic version of this document shall be treated as if it was the production of an original signed copy.

#### Re: Indigenous Knowledge Program Timeline and Update

Dear Chief Solomon Atlookan:

In December 2019, the Marten Falls First Nation (MFFN) Community Access Road Project Team (Project Team) introduced an Indigenous Knowledge Program to support the federal and provincial assessments for the Community Access Road Project (the Project). Since that time the following milestones have been accomplished:

- The Terms of Reference for the Project were approved with amendments on October 8, 2021 by the Minister of the Environment, Conservation and Parks;
- The Notice of Commencement of the Environmental Assessment (EA) was published on October 29, 2021; and
- The federal Tailored Impact Statement Guidelines were issued on February 24, 2020.

The Indigenous Knowledge Program is a critical component of the information base upon which the assessments will be conducted. The information generated through the Indigenous Knowledge Program will be used in tandem with scientific approaches, and both knowledge systems will be used in forming the foundation for baseline conditions, predicting potential project impacts, and determining appropriate mitigation and monitoring methods.

Figure 1: Indigenous Knowledge Timeline (attached) illustrates the key steps in the Indigenous Knowledge Program and their anticipated completion dates. As noted above, the Project Team began communicating with Indigenous Communities in December 2019, and Project funding support for information and data gathering began in the summer of 2020 and is on-going. To more holistically integrate Indigenous Knowledge and information on Indigenous Land and Resource Use into the assessment processes we have targeted a June 30, 2022 deadline for the completion of Project-Specific Indigenous Knowledge/Indigenous Land and Resource Use Studies. We ask that you please let us know if you intend to participate but do not think you can meet this timeline. Further, Figure 1 provides a timeline for ongoing engagement with your community to:

• Validate Indigenous Knowledge/Indigenous Land and Resource Use inputs provided by your community (if applicable);

• Initiate conversations on effects to Aboriginal and Treaty Rights and Interests; and

• Review information on effects on Aboriginal and Treaty Rights and Interests and discuss mitigation.

We hope that the Indigenous Knowledge Program also helps to support your on-going efforts to document and record your oral knowledge for the benefit of your community and future generations. 

Dear Chief Solomon Atlookan and Eabametoong Council,

Thank you for your letter correspondence, dated December 23, 2021, and for sharing your concerns and perspectives with us. First off, my regrets for not responding sooner. We too are busy dealing with COVID-related struggles, community loss, and socio-economic needs like clean drinking water and school capital issues, or lack thereof. We are very sorry to hear of the challenges that the COVID-19 pandemic has had on your community and we are grateful you have reached out. We appreciate how difficult things can be and understand the struggle as we face many of the same issues as Eabametoong First Nation, including housing. We remain committed to working with you to find the best approach to engage and consult with you on our projects.

We would very much like the opportunity to meet with Eabametoong First Nation leadership to renew and strengthen our relationship. I would like to be clear, however, that the Marten Falls First Nation (MFFN) Community Access Road (CAR) and the Northern Road Link (NRL) are separate and distinct projects. The MFFN CAR Project is led by MFFN as the proponent while the NRL is a Joint Co-Proponency Project led by MFFN and Webequie First Nation. These projects are also at different stages of their respective *Environmental Assessment* (EA) and *Impact Assessment* (IA) processes. The MFFN CAR Project commenced the EA Phase of the Project on October 29, 2021. The NRL is currently at the beginning of the Terms of Reference for the EA stage (i.e., the phase in which the framework for the EA phase is set). We have forwarded your letter to the NRL Project Team and Webequie First Nation, and anticipate you'll receive a joint response from MFFN and Webequie First Nation leadership regarding that project.

We would very much like to work with you and your community to co-develop a custom approach to engagement and consultation on the MFFN CAR Project. While some of our engagements and consultations are considered standard and accepted approaches to meet regulatory requirements, we are very open and supportive of finding preferred ways to engage with your community. We would very much like to receive your community's continued feedback as our discussions progress. In addition, we are supportive of your preference for an in-person meeting and will accommodate this preference once deemed safe by public health and your community. In the meantime, we feel it is important for leadership and Project Team meetings to happen soon via teleconference; this will ensure your community has access to the available funding resources to support engagement and consultation in our Project.



As recommended in your letter (sent September 9, 2021 by Rochelle Slipperjack) and our email response on September 20, 2021, we are committed to organizing a meeting between MFFN and Eabametoong First Nation to discuss the development of a Project-specific protocol to guide the way we will engage your community going forward. We suggest an initial teleconference meeting with leadership during the week of April 4, 2022, followed by a meeting with the MFFN CAR Project Team the following week (i.e., week of April 11, 2022.)

With regard to your comments about the Impact Assessment process, we anticipate that an extension to the timelines will be required for the MFFN Community Access Road. We are currently discussing the need and process with the Agency, and our expectation is that we will meet your request for a 6-month extension. Once our discussions with the Agency conclude, we will provide an update on the revised timeline for the Impact Assessment.

With regards to my comments last January regarding consultation associated with the Far North Act, I stand by my words and stand by the Chiefs as a collective. I believe MFFN and those First Nations more directly impacted by the Ring of Fire and Land Resources and Aboriginal and Treaty Rights issues need the appropriate time and resources concerning COVID. MFFN will be here regardless of any political party's timeline and we will always support in principle the Matawa Chiefs on shared issues of jurisdiction acknowledgement and the promise of Treaty 9 sharing the land and its benefits. We hope to reach an agreement together with the Matawa Chiefs on our shared positions on Aboriginal and Treaty Rights. MFFN holds the belief that the Declaration of Unity and the Judicial Review with Cliffs Resources led to the Regional Framework Agreement (RFA) which MFFN was a part of. It was also acknowledged that MFFN had a Memorandum of Understanding table on resource development with Ontario which could not be superseded by the RFA. It must be stated that MFFN was always open to staying at the table, if one was provided, and to reaching an agreement as was the case with the Statement of Commitments, which was a lot of positive work by the collective will of our communities, yet we did not agree to that either as First Nations working together affiliated by the Tribal Council.

MFFN is moving ahead in our planning and building of relationships with governments and businesses on resource development and environmental stewardship as best as possible given the current COVID climate, and the resources allocated to us by the governments. Much like other First Nations in our Tribal Council area are moving ahead with exploration companies, negotiating Impact Benefit Agreements and the actual turning of the shovel on these projects.

Though we have embarked on the path of working directly with the government on resource issues, we feel that it is also our right to own our autonomy as expressed in the Matawa Chiefs past declarations. In the Declaration of Unity, previous MFFN Chief Eli Moonias stated, "Our First Nations do not oppose responsible development, but as a people of the land we want to benefit from mining developments



and negotiate meaningful employment and business opportunities for our communities, while ensuring the environment is not put at risk".

With respect to the EA / IA for our Community Access Road, we are progressing very slowly, far more slowly than if the pandemic had not occurred. I'd like to emphasize that no significant decisions have been made as part of these assessments and that there is still much work and time for your community to be involved.

Again, we would very much like to meet with you as soon as possible to discuss the co-development of a custom consultation process for your community. Please let us know if you are able to meet with us in the coming weeks.

The Community Coordinator Program is funded through the Marten Falls First Nation Community Access Road Project Team; however, the plan is for payment to be issued directly to Community Coordinators through a third-party vendor on a bi-weekly basis. We will have individuals on our team (Indigenous Community Leads) who will help the Community Coordinators fill out an activity tracker and a simple timesheet for submission to the third-party vendor to process payments. This is different to how funding is provided to Ministry of Northern Development, Mines, Natural Resources and Forestry funded position Community Community Dased on milestones). If you would like to discuss a hybrid scenario, we are open to that.

Our suggestion is for community leadership to recommend someone for this position, especially those who are already performing well in the role of the Ministry of Northern Development, Mines, Natural Resources and Forestry funded position Communication Liaisons Officer. 

Thank you for your letter of April 12, 2021, regarding suspension of consultation activities with Eabametoong First Nation on major projects. We recognize that the current situation you describe regarding the COVID-19 pandemic and the housing emergency and crises experienced in the past year by members of your community are having a significant impact. It is also recognized that these issues are making it difficult for your community to devote the necessary time and resources to participate in the Regional Assessment in the Ring of Fire area (Regional Assessment) and the ongoing impact assessments for the Marten Falls Community Access Road and Webequie Supply Road Projects (the Projects).

Given this reality, the Impact Assessment Agency of Canada (the Agency) continues to extend the planning of the upcoming Regional Assessment to ensure effective and meaningful engagement with communities and organizations. Agency officials have advised me that they have recently been in touch with Eabametoong First Nation to arrange a meeting to explore how the Regional Assessment could be undertaken with the full involvement of the Indigenous communities that may be affected by future development in the Ring of Fire area. In light of the circumstances your community is experiencing, the Agency will continue to be flexible in its engagement process.

When you are ready to resume, I encourage you and your representatives to continue to work with Agency officials.

With respect to the ongoing road project impact assessments in the region, Agency officials likewise recognize the challenges posed by the COVID-19 pandemic for your participation in these assessments, and have adapted their conduct to prioritize the health and safety of communities.

The impact assessments for the Projects are proceeding in accordance with legislated time limits. The Agency, upon request by the Proponents, may extend the legislated time limit in this phase of the assessment process under the *Impact Assessment Act*. These Proponent-driven time limits are managed individually and independently from the Regional Assessment. As planning for the Regional Assessment continues, Agency officials will explore the potential relationships between it and the ongoing road projects, including the potential for the Regional Assessment to contribute to these and future projects.

Agency officials will be in touch with you concerning when you and your representatives might be prepared to continue discussions. For planning around the Regional Assessment, I would encourage your representatives to work with Virginia Crawford, Senior Consultation Advisor (*virginia.crawford@canada.ca*). For the two road projects, your team may contact Sean Carriere, Acting Director of Ontario Region (*sean.carriere@canada.ca*).
