Thank you for your comment submitted to the Impact Assessment Agency of Canada (the Agency) on December 9, 2022 regarding the Marten Falls First Nation Community Access Road Impact Statement extension request from Wildlife Conservation Society of Canada. We are happy to share that on January 13, 2023 the Agency issued their decision and granted the extension to the time limit.

We appreciate the support you expressed for our Impact Statement extension request.

Thank you for your comment about some First Nation communities requesting a pause to the Environmental Assessment / Impact Assessment (EA / IA) process due to health, safety and social crises. We appreciate the concerns raised regarding communities' capacity to engage or respond to outreach and consultation requests related to the Community Access Road. As a First Nation Proponent, we have also dealt with similar issues from COVID-related struggles, community loss, and socio-economic needs like clean drinking water and school capital issues, or lack thereof. However, for us, the Community Access Road is an opportunity to improve the lives of community members not only by providing a reliable transportation option but will also help lower the cost of goods and services, increase social interaction, improve access to emergency, health and social services and employment opportunities. Delaying the EA / IA process even further would mean negatively impacting our community.

That being said, the recent Impact Statement extension provides an opportunity for further collaboration and we remain committed to working with Indigenous communities to find the best approach to engage and consult on the Community Access Road. During the Terms of Reference phase, in addition to releasing the draft Terms of Reference in December 2019 for comment and review, Marten Falls First Nation voluntarily offered that the proposed Terms of Reference be available for a 60-day review period, then an additional 30 days offered by the provincial government, totaling 126 days instead of the legislatively mandated 30 days.

Throughout the EA / IA we have made efforts to accommodate the needs and capacity of all interested communities to participate in the process, including offering to hire local Community Coordinators to assist with virtual and socially-distanced community engagement and consultation activities throughout the pandemic. We remain adaptable and flexible with our consultation and engagement approach and take the lead from each Indigenous community to understand how they would like to be engaged during

these times. For example, some communities have been able to continue to participate in the Project using online and phone-in methods to participate in the Indigenous Knowledge Program.

We understand that other projects in northern Ontario, including Webequie Supply Road, the Northern Road Link and the federal government's Regional Assessment, may have overlapping timelines with the Community Access Road resulting in limited capacity for communities and groups to participate. The Community Access Road is distinct from these other projects and are at different stages of their EA / IA processes. The Community Access Road commenced the EA Phase on October 29, 2021 and is well ahead of other road projects in the area that are only now entering the early stages of their EA / IA processes. It would not be prudent to halt progress on the Community Access Road and further delay the deliver of a much-needed community benefit.

Thank you for expressing your concerns about Ontario and the federal government's ability to manage three different road projects. If you haven't already, we encourage you to share these sentiments directly with Ontario and the Agency.

The Request for Time Limit Extension was partially influenced by the delay in field programs commencing, and the need for multi-year/ multi-season data collection required by the Tailored Impact Statement Guidelines.


During 2020 and 2021 our field programs experienced a number of delays related to Covid-19, extreme weather and permitting approvals which prevented us from beginning some programs. For those programs which had a delayed start in 2021, the timeline extension will allow them to satisfy the requirements of the Tailored Impact Statement Guidelines.

We would be happy to host a discussion between yourselves and our technical team to discuss your specific concerns sometime in the future. We have engaged with WCS previously on some of our Study Methods, specifically related to our Wolverine Field Program and value the input and expertise that WCS is able to provide. We look forward to a future release of information, which will describe our study methods and findings. Full technical reporting, as well as a detailed record of consultation and engagement will be available as part of the Draft Environmental Assessment / Impact Statement review (July 2024 anticipated submission).







Thank you for the opportunity to comment on the Request for Extension Report, prepared by AECOM Canada Ltd. and Dillon Consulting Ltd. on behalf of Marten Falls First Nation as the Proponent for the purpose of the Impact Assessment (IA) of the Marten Falls First Nation All Season Community Access Road (MFCAR) Project.

Our remarks draw on our applied and field-based experience as conservation scientists working in the region for the last two decades. Our expertise is in land use planning, impact assessment, and conservation and science research focused on intact forests, freshwater, and peatlands, and the wildlife and fish that rely on these ecosystems.

In summary, we support the request by the Proponent for an extension of three and a half years to July 24, 2026. Of the factors listed in Section 2, we agree in particular that COVID-19 had significant impacts on First Nations communities in the far north in Ontario and have concerns that the Proponent chose not to pause the MFCAR Project despite First Nation community requests to do so given health and safety concerns, capacity, and social crises. We continue to think this experience highlights the limitations of impact assessment as a tool for social justice in northern Ontario.

We appreciate that the COVID-19 global pandemic, starting in March 2020, affected the ability of the Proponent to address the IA and provincial Environmental Assessment (EA) for the Project resulting in delays to the collection of baseline data from field surveys and also forced the Proponent to create and establish virtual options for consultation and engagement with First Nations, the public, and stakeholders to meet the timelines established under *the Impact Assessment Act*, 2019.

However, we take this opportunity to highlight that a number of First Nation communities requested the Proponent pause this IA/EA process due to health, safety, and social crises that





affected capacity of Indigenous communities to respond. These requests were not taken up by the Proponent. The Impact Assessment Agency of Canada (IAAC) was also impotent in the face of these requests.

We also highlight that both the IA for the Webequie Supply Road (WSR) Project and the federal government's Regional Assessment for the Ring of Fire were also occurring at the same time. While the Proponent may argue these issues are beyond the scope of the MFCAR Project, multiple IA/EA processes have cumulative demands on time, resources, and capacity for engagement, consultation, and commentary.

In Section 2, a delay in the provincial Terms of Reference (TOR) was also noted as a cause for the delay. As we noted in our comments on the provincial MFCAR TOR in December 2020, we remain concerned and skeptical about the ability of Ontario, specifically MECP, to manage up to 3 individual road segment projects in coordination with the federal government to develop one north-south industry supply road to the Ring of Fire. Given Ontario's efforts to reduce red tape and be more efficient, we see the current piecemeal approach to impact assessment of roads to the Ring of Fire as an excessive yet inadequate approach to enhance so-called community access. There should be clearer descriptions of how the six disparate assessment processes will be coordinated, i.e., between Ontario and IAAC, including between the different road segment "projects", and between the federal regional assessment and this project. Part of the issue is driven by the piecemeal approach and dividing the Projects into multiple segments.

While we overall support the Request for Time Limit Extension, we do have some concerns that the interruptions and delays in data collection may impact the quality of data collected, and the usefulness of collected data to informing potential impacts on ecosystems and wildlife. However, the Request for Time Limit Extension provides only a very brief overview of the extent and types of engagement with Indigenous communities, the public, and stakeholders, field work conducted to date, secondary sources reviewed, progress to date, and the planned revised schedule. There was not sufficient detail provided on the sampling and field surveys in the Request for Time Limit Extension to provide comments on these aspects, or how the request for an extension may impact the data collected. Therefore, our recommendation is that the Proponent provide more detail on how data collection was impacted, and how data collection will be undertaken under the revised timeline, in order to address these concerns.





What's Happening and When?

Field studies to document the presence of ungulates (moose, moozoog; caribou, atigwag) and other wildlife in the study area are continuing for the federal Impact Assessment (IA) and provincial Environmental Assessment (EA) for Marten Falls First Nation's proposed All Season Community Access Road.

The following winter field programs will occur between January and March 2022, with exact dates being provided once confirmed:


- Furbearer ground track surveys (two rounds of five days between January and February): will be
 conducted by track specialists. Transects, or straight lines through the study area, will be walked to
 document the number of track sets crossing the transect, species, location and habitat type
 encountered. Timing will be related to optimal snow conditions.
- 2. Winter ungulate aerial surveys (15 days between January and March): will be conducted using a fixed wing aircraft and helicopter to estimate the distribution of wolverine and caribou to determine caribou calf survival in the study area. Timing will be related to optimal snow conditions.
- 3. Wolverine (wishkobishag, wiingwa'waakeg) hair snag surveys (monthly trips from February to May): 54 hair snag traps will be placed in the study area. Remote cameras will monitor the baited hair snag traps to help confirm if a wolverine has visited the hair snag trap.







Thank you for your email dated May 3, 2022. We apologize for the delay in responding and thank you for your patience.

Marten Falls First Nation (MFFN) has a winter access road, but its condition varies, making transportation of goods and people to and from the community unreliable; ultimately impacting the community's well-being. As a result, the MFFN community is proposing an all-season Community Access Road (CAR) that will connect the MFFN community to Ontario's provincial highway network (Highway 643) to the south via the existing Painter Lake Road. MFFN, as the Proponent of the Project, has formed a MFFN CAR Project Team (the Project Team) that includes MFFN CAR Community Member Advisors and MFFN CAR Project Consultants who act with input, guidance, and direction from the MFFN Chief and Council. In addition to federal and provincial regulations, the Project meets MFFN requirements. Please note that the CAR does not include a road to the Ring of Fire. The road to the Ring of Fire is a separate project, called the Northern Road Link Project, which if built would connect to the Project.

The Project is listed as a physical activity requiring it to go through the federal Impact Assessment (IA) process (Impact Assessment Act, 2019). In addition to the federal requirements, the Project Team voluntarily entered into an agreement to have the Project go through the provincial Environmental Assessment (EA) process (Environmental Assessment Act, 1990). As such, the Project will go through a coordinated provincial/federal process referred to as the EA/IA process.

To meet the provincial requirements the Project Team prepared a proposed Term of Reference (TOR) in accordance with the *Ontario provincial Environmental Assessment Act of 1990*. It should be noted that while the 1990 version of the Act is the overarching regulation, amendments are made from time to time and the Terms of Reference was developed in accordance with the regulations in place at the time of submission, and the EA will be developed in accordance with updates in place at the time of that submission.

The Project Team has identified 23 Indigenous communities, Tribal Councils and Provincial Territorial Organizations that have the potential to be impacted by the Project. These groups have been and will continue to be consulted and engaged with on Project activities and have been encouraged to share feedback on the EA/IA.

The Impact Assessment Agency of Canada is leading the regional assessment, and we will forward your comment regarding a comprehensive, First Nations co-led and co-enforced Regional Impact Assessment of the Ring of Fire to them so they can reply directly. In the meantime, we are tasked with moving our environmental assessment process forward.

We hope this answers some of your questions and comments. If you have additional questions please respond to this email.

Thank you for your continued interest in the Community Access Road. We understand you are looking for information about how stakeholders (like tourism operators) potentially impacted by the Community Access Road could be compensated financially.

The response we sent on September 2, 2021 (also attached for your reference) mentioned how we are unable to predict the economic impacts that the road might have on tourism operators in the region until more work is completed throughout the Environmental Assessment. Without having the assessment of effects, it is premature to discuss mitigation for those effects (i.e. compensation, including where and how much would be appropriate). The Environmental Assessment officially started on October 29, 2021 and is expected to take multiple years. You, and other interested stakeholders, will be kept informed and given opportunities to discuss potential effects and mitigation throughout this process.

As part of the route assessment work, we will initiate and continue discussions with tourism operators to receive input including concerns that they may have on the alternative routes and potential impacts surrounding them. The comments you have provided so far have been documented formally and will be considered in our assessment. Do you have additional information on the brook trout spawning locations based on our previous correspondence? If so, we can provide zoomed in maps once you have identified the general spawning locations. Please see the attached email that requested this information on April 27, 2020.

Although it is too early in the Environmental Assessment to discuss the potential for compensation, we would be happy to give you a call to discuss the overall status of the Environmental Assessment and the process for understanding potential effects as a result of the road construction. If so, please let us know when you would like to meet via teleconference in November or early December. We welcome ongoing discussions with 7 Lakes Wilderness Camp throughout the Environmental Assessment.

Hi Brad.

Thank you for your response and expression of specific concern about the potential impact of the Community Access Road on the Dusey River / Lake and Albany River / Teabeau Lake camps.

The project is currently in the Terms of Reference (ToR) stage and awaiting approval on the ToR from the Minister of Environment, Conservation and Parks (MECP). Once ToR approval is received, the EA stage will commence and will include work to assess and evaluate the alternative routes. A preferred route will then be identified. The level of public access that will be allowed on the road is also to be determined as this is a comment that has been expressed by some Indigenous community members as well. The need for mitigation, impact management measures and perhaps compensation would then be determined. Until then, we are unable to predict the economic impacts that the road might have on tourism operators in the region.

As part of the route assessment work we will be reaching out to tourism operators to receive their input including concerns that they may have on the alternative routes. We are hopeful that this work can commence later this year. We will be reaching out to you to receive your input.

This EA study is expected to require several years to complete and then will then undergo a lengthy Provincial and Federal government review and approval decision process. This is required before any construction on the project can begin.

I discussed the Brook Trout spawning grounds with your representatives at the open house meeting in Thunder Bay in 2019. They expressed interest and concern for this matter. They believed the crossing could be changed to help with this. Also know this, your project affects not only our Dusey river/lake operation but also our Albany river/Teabeau lake operation. Colectively these two systems account for our best Moose Hunting and fishing we have to offer, which are marketed as wilderness experiences. Once you access these two systems our business is done at those sites. Hunters will not pay to Hunt areas that are being Hunted by local populations. Fisherman will not pay to fly into rivers and lakes being fished by local populations. No one is going to pay us to fly into a wilderness area that is no longer really wilderness, with trucks and vehicles crossing the rivers, boats stashed by the crossings, and locals boating all over the system for purposes of Hunting and Fishing. Besides the investment we have in camps and equipment on these systems these two camps represent about 50% of our annual sales for the outpost camp business we operate annually. We can no longer market "Wilderness trips" as our name alone states, with roads, bridges, crossings and local access. We know full well the damage this will do to our business and lots of terminology will not convince me otherwise. We also know we cannot stop this road, that is not our intention. Our purpose in our communications is to express the loss we will realize in the expectation that you have plans to Financially compensate us for our losses. Hi Brad,

Thank you for your interest in the Marten Falls First Nation Community Access Road (CAR). You inquired about potential changes to Brook Trout spawning habitats, changes to fishing and hunting access, and how this might impact local businesses.

Based on the results of the fish and fish habitat assessment completed for the Community Access Road (CAR) on September 8, 2019, it is acknowledged that there is potential spawning habitat for Brook Trout at the Dusey River crossing. The Dusey River was surveyed 100 m upstream and 200 m downstream of the proposed crossing. The crossing was in flat habitat with mixed substrates of cobble, gravel, boulder, sand and silt. In addition to the spawning habitat, the surveyed section has moderate to high overwintering potential for most fish species as average water depths were greater than 1 m. Rearing habitat (i.e., areas where larval and juvenile fish find food and shelter) was rated as moderate for large-bodied species such as Walleye and Brook Trout and for small-bodied species such as Brook Stickleback. Potential rearing and spawning habitat for Northern Pike was low due to limited aquatic vegetation. The mix of coarse substrates provides moderate potential spawning habitat for large-bodied fish (e.g., Walleye, White Sucker and Brook Trout).

Fish sampling in the Dusey River was also conducted for the CAR in 2019 and for the Cliffs Chromite Project in 2012. No fish were captured in 2019; however, one Yellow Perch and two unidentified darters were observed. Brook Trout, Yellow Perch, Longnose Sucker, White Sucker, Shorthead Redhorse, Pearl Dace, Common Shiner and Blacknose Shiner were captured during the 2012 Cliffs Chromite Project fish sampling program.

It is important that MFFN is aware of the presence of features and businesses in proximity to alternative routes, so they are considered in the Environmental Assessment (EA) process. The EA will assess potential effects of the alternative routes on tourism operators by evaluating predicted changes on the basis of the 'Recreation and Tourism' criterion (see Appendix A of the Terms of Reference which is available for download here .). In undertaking this assessment, we will be reaching out to potentially affected tourism operators to better understand their concerns. As well, as part of the assessment, impact management measures will be recommended to avoid and / or minimize the predicted effects. This could include measures to minimize effects that could disturb operations of existing tourism outfitters, or as part of design development of alternative route alignments and watercourse crossing locations. The EA will also assess potential effects of the alternative routes on fish and fish habitat by evaluating potential effects of ish habitat quantity and quality; use and access to habitat and migration; and survival, reproduction and abundance (see Appendix A of the Terms of Reference). This includes assessing potential effects from placing crossing structures on waterbodies and potential effects from changing public access to recreational angling areas. Any such effects will be identified in the EA.

The expectation / goal of the project is to rely on design measures and mitigation strategies to maintain existing environmental conditions to the extent possible with any potential effects being minimized or avoided altogether. As such, critical environmental receptors, or resources such as the Brook Trout fishery on the Dusey River would be aligned and held to this same benchmark in project planning / implementation.

Terms of Reference

The Proposed Terms of Reference is with the Ministry of the Environment, Conservation and Parks for review and a decision by the Minister. Stay tuned for more information.

Air Quality Program: In May 2021, we successfully installed monitoring equipment in MFFN to better understand air quality and weather conditions. Two MFFN community members were hired as monitors and trained to use the equipment.

Bat and Remote Camera Installation Update: The Bat Monitoring Program and the Remote Camera Installation Program happened at the same time (from June 7 to June 16, 2021). For the bat program, audio recording devices were installed to document bat species presence and distribution in the Local Study Area. For the Remote Camera Installation Program, motion-sensitive cameras were installed in the Local Study Area to document the presence and seasonal patterns of caribou (atik), wolves (maihgan), moose (mooz) and other animals. One MFFN community member was hired as field support staff. The Field Crew completed this work on June 15, 2021.

Thank you for your email regarding the Marten Falls Community Access Road (the Project), and the concerns you have expressed. We can confirm that your comments and information provided have been circulated among the Project Team.

The Environmental Assessment / Impact Assessment (EA/IA) process is currently underway to assess and evaluate the alternative routes the proposed Community Access Road might follow. The alternative routes assessment and evaluation will consider potential effects on the social, cultural, economic, built and natural environments, including an assessment of the potential effects on outfitter operations like yours. The studies we conduct and the consultations we deliver will help us choose the preferred route to the community.

Once the assessment of effects is completed, including any on local outfitting operations, the need for mitigation measures and perhaps compensation would be determined. The expectation / goal of the Project is to rely on design measures and mitigation strategies to maintain existing environmental conditions to the extent possible. As part of the EA/IA process, we will have follow-up conversations with all outfitters potentially affected by the construction and / or operations of the Community Access Road.

Your business is an important contributor to the local economy and we understand that much of the value is the remoteness of the camps and the limited access to your hunting and fishing locations. Changes to this and the effect this could have on your operations would be considered in the determination if compensation might be needed to offset any effects to your operations. Please note that if approved, it could be as many as 10 years until construction of the road begins.

As we complete the EA/IA process, we encourage you to continue to participate in the engagement sessions to stay upto-date on the Project status. There will be Public Information Centres (PIC) in Thunder Bay on June 27th and another in Geraldton on June 29th. Members of the Project Team will be present at these PICs to answer any questions you may have and to gather your feedback. 
About the Project

The ToR serves as a framework for the preparation and review of the EA for the proposed Project, and the Project is now in the EA phase of the provincial process. The federal



Government published a Notice of Commencement of the IA on February 24, 2020 and the Project is now in the Impact Statement phase. This is the first Public Information Centre held after ToR approval to support the EA processes; both EA and IA.

Hi.

I hope this message finds you well! I coordinate a bat conservation project at the Toronto Zoo, and I am currently working on a report collating existing data and identifying knowledge gaps for bats in the Far North Ontario region. This report was commissioned by the Canadian Wildlife Service ahead of the forthcoming Ring of Fire Regional Assessment, given the limited data available for bats.

In my searches, I came across your September 2021 Field Notice, which mentions bat monitoring. If you have a few moments, it would assist me greatly to hear your thoughts on the quick questions below:

- 1. Is it OK for me to mention in the report that this monitoring is taking place? Even if no further information can be shared, it is valuable to acknowledge that these datasets exist.
- 2. Are you able to share any details of bats detected through the monitoring to date? I'm mostly interested in the species detected and approximate locations. However, I completely understand if this is not feasible at this point, due to project confidentially, a need for community consultation, or other factors!
- 3. Are you aware of / responsible for the observations of bat houses and occupied structures reported to the Neighbourhood Bat Watch project? The Zoo is a partner in bat watch, and so I have access to these data, and I have been trying to track down contact details to reach out to the report submitter. Seeing the proximity, I wondered if they happened to be related to your project.

Good afternoon,

Thank you for reaching out to the Marten Falls First Nation Community Access Road (MFFN CAR) Project Team.

The MFFN CAR has two videos, on the general study of birds, available on the Project website: Birds webinar (here) and the study of birds (here).

The bird field study program for the Marten Falls First Nation Community Access Road took place between 2018-2022. Field studies showed that palm warblers were most commonly found in marsh and swamp habitat, as well as in coniferous forests near water, such as bog, fen, and water habitats. Field studies also found that palm warblers like to live in places that recently had low-intensity forest fires, and forests with insect outbreaks (because there are lots of bugs to eat!). While palm warblers preferred these other habitats, researchers found them at nearly every location in area being studied for the project, during the spring, summer, and fall seasons. Palm warblers were most commonly detected in the morning, at dawn. During the winter, palm warblers migrate to the United States, Central America and the Caribbean.

Palm warblers prefer their habitat to cover large areas, rather than small patches broken up amongst other habitat types. This can make them sensitive to disturbance from humans. Field studies for the Marten Falls First Nation Community Access Road found that the area had a large patch of habitat for palm warblers. Within the regional study area (outlined by the black solid line on the attached map), there are estimated to be between 1,591 to 5,966 palm warbler nesting territories.





I am disappointed that the MFFN transport consultation did not also consider 'suspended monorail'. I include where a video describing the Quebec technology. I also live in a hydro-dams damaged territory in Central Labrador (see Churchill Falls and Muskrat Falls,, NI Hydro) and now talk of Gull island!

What is appealing about suspended monorall systems is that the environment is much less affected, hydro and wifi can be delivered to the communities, and not only passengers, but freight (tonnes/car) can also be accommodated. And of course such a system, run by hydro, eliminates the need for fossil fuel in transport. Certainly here in Labrador, the Inuit want to protect their hunting environment in the north, and could do so with suspended monorall. Tourist attraction is obvious. This email address was passed on by the office of Greg Rickford after I inquired about looking for a way to help with developing infrastructure and training necessary for the production of concrete in a manner that would make the community less reliant on bagged cement.

Previously I had listened to a CBC radio interview with the Chief of Marten Falls where he expressed legitimate concern about winter roads holding up until necessary construction materials for priority projects could be delivered to site.

I am wondering if there is interest in working toward establishing the infrastructure necessary to deal with bulk cement and eliminate dealing with bags. A good portable concrete plant can be purchased for \$150,000 and can be moved from community to community depending on project locations. Portable cement storage adds to capacity. Possibly you have a Construction Manager that is familiar with the challenges.

My background includes many years of remote, temperature controlled concrete production experience including foreman positions at the Victor Diamond processing facility project near you as well as the Wuskwatim and Keeyask hydro generating projects in northern Manitoba. Dear Invitation to Voices project team,

Thank you for your comment submitted to the Impact Assessment Agency of Canada (the Agency) on December 6, 2022, regarding the Marten Falls First Nation Community Access Road Impact Statement extension request.

We appreciate you taking the time to explain the mandate and purpose of Temiskaming Native Women's Support Group, including Keepers of the Circle and Invitation to Voices project team. We also appreciate your agreement with the Impact Statement extension request. We are happy to share that on January 13, 2023, the Agency issued their decision and granted the extension to the time limit.

Thank you for providing additional recommendations on engagement.

Related to the collection of socio-community and health information, the study team are targeting sub groups including women, gender diverse people and Elders. Subject to the support of the community, this includes the conduct of focus groups with women from communities in our local study area. We are also conducting community representative interviews with a cross section of community members and have plans for the release of an on-line survey that people can complete anonymously. We also plan to make our Marten Falls First Nation Community Coordinator available to assist anyone in the completion of the surveys, and have plans to conduct sessions specifically targeted at youth to receive their perspectives.

We appreciate your feedback on the two-day Aboriginal and / or Treaty Rights and Interests (ATRI) Forum (the Forum). The Forum took place February 2023 in Thunder Bay. We would like to clarify that the Forum was not a public event, it was a closed Forum with invitations extended to those Indigenous communities who are scoped into the Marten Falls First Nation Community Access Road, Webequie Supply Road (WSR) and Northern Road Link (NRL) project assessments. To help support communities in participating, the Province of Ontario provided funding to support costs associated with travel for three community representatives. We are looking at ways to host a similar event later this year given the positive feedback we received from some participants.

As a First Nation proponent, it is the goal of MFFN to work collaboratively with Indigenous communities to understand community-specific ATRI within the Community Access Road Project area. The ATRI assessment is ongoing and will continue throughout the assessment processes. We appreciate your sentiment about reducing barriers to disseminate information to rural remote communities. Our team





makes efforts to follow-up with communities by phone call and offer to meet both virtually and inperson, based on each communities' preference.

The Forum was an initial step in working towards developing a shared understanding of ATRI within the Community Access Road Project area. By developing an understanding of Rights and Interests we will be better positioned to engage with Indigenous communities about potential Project(s) impacts. Together, we can then look at ways of avoiding, mitigating or reducing potential negative impacts while enhancing potential positive impacts related to ATRI. As a First Nation Proponent, we understand that the conversations at the Forum were preliminary in nature and that communities need time to think, reflect and discuss with leadership and other community members on what they want to share with us regarding ATRI. We continue to offer to meet individually (in-person or virtual) with all Indigenous communities to further discuss potential impacts to ATRI and we will continue to do so throughout the assessment processes.

We are working directly with communities to share information with membership in ways that work best for each community. One such initiative is the Community Coordinator Program. One of the key objectives of the program is to provide a local face and voice for the Community Access Road incommunity. The intention is that membership will have a familiar person to go to ask questions, provide feedback and learn more about the Community Access Road. The coordinator also provides our team with advice and guidance on how to appropriately engage with their community and helps involve the whole community in the Environmental Assessment process.

In 2019, we launched the Indigenous Knowledge (IK) Program for the Community Access Road. The IK Program is a critical component for assessing potential Community Access Road impacts including impacts to ATRI.

The IK Program involves two key ways for information gathering and sharing:

- Sharing existing and relevant IK and Indigenous land and resource use information previously collected by communities (e.g., for community-based land use planning) with the MFFN Community Access Road Project Team; and
- Completing Project-specific IK and Indigenous land and resource use studies to collect relevant IK and information on Indigenous land and resource use in the vicinity of the Community Access Road.

Given the sensitive and confidential nature of IK, we understand that most communities prefer to complete their Community Access Road-specific IK studies on their own or using their own consultants and then share a report and mapping with the Community Access Road Project Team. Our goal is to respect the approach each community prefers to take. Best practices shows that data collection is typically done in person respecting the cultural practices and customs of the participating community.





We have also provided a funding opportunity for Indigenous communities to participate in the IK Program.

The COVID-19 pandemic restricted any in-person collaboration. However, with restrictions lifted, our goal is to be able to meet in-person with communities to collaborate on how IK and information on Indigenous land and resource use can be woven into the assessment processes. Our approach is to collaborate with communities to evaluate the severity of impacts on Rights and to inform and directly contribute to the identification of mitigation measures to eliminate, reduce, control or offset adverse impacts. This will be done through a variety of ways including in-person meetings, workshops, virtual sessions and other forms of correspondence.

As noted above, in addition to conducting interviews with community representatives and holding focus groups with youth / women / Elders, we plan to make an on-line survey available for both on and off reserve community members to complete. The survey is being developed with the assistance of community members. Support will also be offered for those needing assistance to complete the survey including access to a computer / internet. We note that on-line surveys are being conducted because inperson surveys were determined not to be suitable for the target communities as per input received from the community.

Please let us know if you would like to meet with the Marten Falls First Nation Community Access Road Project Team to learn more about the Community Access Road or if you have additional questions and comments. We also noticed that your organizations / groups aren't on our electronic contact list, would you like to be added?

Keepers of the Circle is operated by the Temiskaming Native Women's Support Group, an Indigenous Family Learning Center in Kirkland Lake and Temiskaming Shores. Our mandate is to maintain quality programing for Indigenous children, women, and families through implementing various projects such as, employment training, healthcare, childcare and more. Our organization works closely with our partner the AnanauKatiget Tumingit Regional Inuit Women's Association (ATRIWA) to raise capacity for Indigenous women, girls and gender diverse persons in Northern Labrador as well as in Northern Ontario to participate in Impact Assessments.

While Indigenous Peoples are frequently regarded as key partners in project assessments, Indigenous women's concerns and aspirations regarding industrial projects have historically been marginalized, as have the opportunities and benefits from such developments. Indigenous women, girls and gender diverse persons are frequently made invisible in impact assessment processes and their systematic exclusion has contributed to the significantly higher rate of gendered violence, poverty, and homelessness experienced. These trends are explained further in national publications such as the Final Report of the National Inquiry into Missing and Murdered Indigenous Women and Girls. Our project aims to help remediate intergenerational impacts of colonization that contribute to systems that have oppressed and marginalized Indigenous women from decision-making processes that affect their wellbeing and economic security. Our organizations explicitly requests that steps are being taken to ensure that Indigenous women, girls, and gender diverse people are being included in decision making for this project and that their input is being thoroughly considered with tangible, measured mitigation of impacts. We would like to ensure that surrounding First Nation communities and urban Indigenous people have been sufficiently informed in advance of project developments and are given support and time to provide input.

This comment is in response to the request for timeline extension submitted by AECOM, WSP and Dillon. Our team has carefully reviewed the proposal for extension and wish to extend our agreement with the stance that the proponent has taken in this matter. It remains clear that there is insufficient data collection occurring that would represent the interests and priorities of the Indigenous communities impacted by the project development. It remains a crucial piece in land use, cultural practices, and historic and current land use practices. This request for timeline extension reflects the needs of community for further time and consideration of all knowledge holders and key information sessions. The proposed plan for engagement is thoughtfully planned and timed, however we would include recommendations on method of engagement and inclusivity parameters.

The plans to hold a two-day open house for people to attend could be duplicated on a monthly or bi-weekly basis, to ensure that space is held for people who cannot make the open house timeline, there is only one opportunity to get information about impacts to treaty rights. The information is distributed in newsletters and emails which is a conventional and appropriate way to communicate in many spaces, however due the communities being rural remote there remains significant barriers in the dissemination of information using this format alone.

The workshop scheduled in Thunder Bay is a great initiative, there will be multiple (frequency unknown) opportunities to provide information and insights that the proponent will utilize in planning the project impacts. For the sharing of ATRI Assessment Effects and Mitigation Discussion is reserved for communities to ask for a workshop upon request. How will the requests be made? What efforts will there be to ensure that the findings make it to the membership of the impacted communities? Once the parameters have been established through the workshop there will only be an opportunity for community members to review the conclusions of the study, concerns brought forward might not have sufficient time necessary to be fully investigated by the proponent.

For the finalizing of the rights impacts document and Indigenous Knowledge survey there remains significant opportunities to conduct meetings in person in communities that will be impacted. The tendency to focus on virtual meeting spaces limits the ability of non-technology accessing people to attend, and when technology is available internet accessibility is extremely limited and drops frequently in signal strength, leading to poor quality and understanding of what is being said between people in the meeting. Having more in-person engagements with multiple opportunities to attend each session is more effective in ensuring people have the chance to attend.

Beyond the limitations of the ATRI open house and workshops, significant emphasis is placed on interviews with key people about a range of topics for the study on socio economic impacts. Little is described in the section about key interviews that would be conducted in community about health, social economic and land impacts, though this comprises a significant level of activity for quarter one of 2023. In planning these interviews the demographic sampling must be reflective of a range of lived realities and areas of expertise. To achieve thoroughness and rigor in this area of study interviews and workshops must centre and include Elders, Youth and Indigenous women, girls and gender diverse persons. There remains significant historic lapse to account for socio-economic impacts in large development projects and it remains acutely tied to the health, security and safety of the people who are living in and around the project area. Ensuring the demographic sample size accurately reflects the population of the communities that are being studied and includes a range of membership when considering scope and study parameters for project impacts.

The tendency to focus on virtual meeting spaces limits the ability of non-technology accessing people to attend, and when technology is available internet accessibility is extremely limited and drops frequently in signal strength, leading to poor quality and understanding of what is being said between people in the meeting. Having more in-person engagements with multiple opportunities to attend each session is more effective in ensuring people have the chance to attend.

Beyond the limitations of the ATRI open house and workshops, significant emphasis is placed on interviews with key people about a range of topics for the study on socio economic impacts. Little is described in the section about key interviews that would be conducted in community about health, social economic and land impacts, though this comprises a significant level of activity for quarter one of 2023. In planning these interviews the demographic sampling must be reflective of a range of lived realities and areas of expertise. To achieve thoroughness and rigor in this area of study interviews and workshops must centre and include Elders, Youth and Indigenous women, girls and gender diverse persons. There remains significant historic lapse to account for socio-economic impacts in large development projects and it remains acutely tied to the health, security and safety of the people who are living in and around the project area. Ensuring the demographic sample size accurately reflects the population of the communities that are being studied and includes a range of membership when considering scope and study parameters for project impacts.
